## We are 私たちは、

- Our office is a company that specializes in Quantity Surveying (QS) services at the construction industry.
- 私たちのオフィスは、建設分野Quantity Surveying(QS)サービスを専門的に提供 する会社です。



- Tristan Kim, who established our office, has leading experiences in QS and Construction
  Management (CM) for large-scale projects with a total cost of approximately 3 trillion KRW,
  including Songdo International City Development Project, Jeju Shinhwa World Development
  Project, and Jeju Odeungbong Neighborhood Park Special Project.

- Based on these experiences, we provide specialized QS services mainly for small and mediumsized projects with a project size of 200 billion KRW or less.

- In small and medium-sized projects, QS companies often place its employee with insufficient experience or no professional qualifications at the Client's business site. In this case, the Client does not fully enjoy the effectiveness of the QS service even after signing a QS service contract.
- 中小規模のプロジェクトでは、QS会社がキャリアが不足している、または専門資格のない従業員を発注先の事業現場に配置する場合がよくあります。この場合には、発注者は、QSサービス契約を締結しても、QSサービスの効果を十分に享受できなくなります。

- The Client needs to urgently deploy a qualified Quantity Surveyor because its project is most important right now.

#### **Customized Services** カスタマイズされたサービス

- **Telephone Consultation**: We provide PM / Cost / Contract / Dispute management consulting service for your construction project through telephone.
- **電話相談**: 電話で、お客様の建設プロジェクトのPM/コスト/契約/紛争管理コンサルティングサービスを提供しています。

- **Visit Consultation**: Customers who wish to visit our office for consultation will not be charged a separate consultation fee for only once (within 1 hour). Consultation fees will be charged from the second time

- **Business Trip Service**: We provide on-site business trip service on an hourly basis without formal QS and PM service standard contracts.

- **Dispute Management Service**: If there is a dispute between the Client and the Contractor, QS will proceed to the on-site dispute mediation committee as a third party. Through in-depth dispute settlement procedures, we create mediation results that can be mutually agreed upon by both management and working staff.

- **Freelancer Service**: Freelance QS service on a daily basis is provided to small and medium-sized companies that are difficult to hire full-time QS. In particular, by maximizing the quality of writing contracts, we guarantee the effect of preventing the risk of disputes against large companies.
